### PROPOSED RESOLUTION FOR CONSIDERATION BY BOARD OF FINANCE ON AUGUST 16, 2023

Establishment of Non-Lapsing Account for the Kent BOE

WHEREAS Connecticut General Statutes Section 10-248a (the "Statute") provides that a board of finance may deposit into a non-lapsing account unexpended funds from a prior fiscal year's budgeted appropriation for education for the town; provided (1) such deposited amount does not exceed two per cent of the total budgeted appropriation for education for such prior fiscal year, (2) each expenditure from such account shall be made only for educational purposes, and (3) each such expenditure shall be authorized by the local board of education for such town, and

WHEREAS the Kent Board of Education ("BOE") has advised the Kent Board of Finance ("'BOF"), and the Kent Treasurer has confirmed that a substantial surplus of unexpended funds remains of the funds in the BOE budget for the fiscal year ended June 30, 2023, (the "2022-2023 fiscal Year"); and

WHEREAS the BOE has requested the BOF to create a non-lapsing account of \$70,000 of such unexpended funds from the 2022-2023 Fiscal Year (which constitutes less than two percent of the BOE's total appropriation for such fiscal year).

#### NOW THEREFORE, BE IT RESOLVED BY THE BOF AS FOLLOWS:

The Treasurer is hereby directed to establish a non-lapsing education account (the "Account") and to deposit \$70,000 of the BOE's unexpended funds from its 2022-2023 Fiscal Year Budget into the Account.

The funds in the non-lapsing education account are to be expended by the BOE in its sole-discretion, but only for educational purposes consistent with the requirements of the Statute. The BOE shall report to the BOF at the end of the current fiscal year as to how the funds were spent.

All other unexpended funds from the BOE 2022-2023 Fiscal Year budget in excess of \$70,000 are to be transferred to the Town of Kent General Fund Undesignated Fund Balance.

Any unspent funds remaining in the non-lapsing education account at the end of the current fiscal year June 30, 2024, shall be transferred to the Town of Kent General Fund Undesignated Fund Balance, unless a carryover to the next fiscal year is approved by the Board of Finance.

In future years, if the Board of Education wishes to add unexpended funds to the non-lapsing education account, it must make a formal request and receive approval from the Board of Finance.
