Unassigned general fund proposed transfer: Mr. McWhinney made a motion to transfer \$388,500 from the unassigned general fund to the Fiscal Year 2018-2019 budget. Mr. Blackketter seconded the motion, and the motion was approved unanimously.

Proposed transfer to Capital Fund: Mr. McWhinney made a motion to transfer \$758,700 into the Capital Fund for Fiscal Year 2018-2019. Mr. Blackketter seconded the motion, and the motion was approved unanimously.

Proposed Net Grand List: Mr. McWhinney made a motion to accept the Proposed Net Grand List of \$604,164,826 for Fiscal Year 2018-2019. r. Blackketter seconded the motion, and the motion was approved unanimously.

Proposed Tax Collection Rate: Mrs. Goodsell made a motion to set the Tax Collection Rate assumption for Fiscal Year 2018-2019 at 99%. Mr. Blackketter seconded the motion, and the motion was approved unanimously.

Proposed Tax Collector's Assumption of net-based collections: Mrs. Brady made a motion to approve the Proposed Tax Collector's Assumption of net-based collections of \$11,245,955 for Fiscal Year 2018-2019. Mr. Blackketter seconded the motion, and the motion was approved unanimously.
