## **Executive Session – Schaghticoke BIA Application:**



## Dear Members of the Board:

On January 4, the Board of Selectmen will consider appeal of the Connecticut Siting Council's decision to allow construction of a cellular tower facility on Richards Road. As a taxpayer, I write to express my opposition to the Town's participation in such an appeal.

Despite the solid arguments ably presented by the attorneys in opposition to the tower facility, the Council chose to place a modified tower on the Richards Road site. In so doing, the Council rejected small cells technology as an alternative to the tower.

However, before undertaking an appeal of the Council's decision to approve a tower on the Richards Road site, I urge the Board of Selectmen to weigh the time, effort, and money required for an appeal against the odds of success.

Appeals of administrative actions of state agencies face challenging standards of review. The scope of review in an administrative appeal, such as this case, is limited. *See Lawrence v. Kozlowski*, 171 Conn. 705 (1976). Courts generally will <u>not</u> substitute their judgment for that of an administrative agency. The judicial review portion of the Uniform Administrative Procedure Act (UAPA), C.G.S.A.§ 4-183, states, in part, that:

The court shall affirm the decision of the agency unless the court finds that the substantial rights of the person appealing have been prejudiced because the administrative findings, inferences, conclusions, or decisions are: (1) In violation of constitutional or statutory provisions; (2) in excess of the statutory authority of the agency; (3) made upon unlawful procedure; (4) affected by other error of law; (5) clearly erroneous in view of the reliable, probative, and substantial evidence on the whole record; or (6) arbitrary or capricious or characterized by abuse of discretion or clearly unwarranted exercise of discretion.

Factual determinations of the agency are upheld if there is substantial evidence in the record to support such a finding. O'Rourke v. Commissioner of Motor Vehicles, 33 Conn. App. 501 (1994).

Even a Plaintiff's demonstration of error on the part of the agency is insufficient for a court to reverse the agency's decision. Section 4-183 (j) permits the Court to overturn an agency's decision only if "the court finds that the substantial rights of the person appealing have been prejudiced".

While the Council missed an opportunity to embrace improved technology in the form of small cells, the Council nevertheless aimed to foreclose appeal to Superior Court by issuing 214 Findings of Facts to support its decision. These Findings of Fact are geared toward stopping an appeal, and specifically addressed the small cell technology in 18 separate findings of fact. (See Siting Council's Findings of Facts 82-93).

Challenging these findings, particularly on technical matters related to cellular systems that the Court may view as within the expertise of the Council, is an uphill task. The potential benefit of such a costly appeal would be highly speculative, given the chances of a successful appeal.

Furthermore, even assuming another party would fund the appeal, the Town's participation would amount to opening "Pandora's Box". Even in the event of a successful appeal, the Court could still remand the entire matter to the Council, which would in turn reopen consideration of both cell tower sites, as well as the height of the tower. Moreover, re-hearing at the Council would entail yet more time and expense for the Town. The Siting Council voted overwhelmingly that a tower facility was more appropriate than small cells.

The Board is already familiar with the cost to the Town of this almost year-long action with the Siting Council. Furthermore, as Chairman of the Kent Zoning Board of Appeals, I am all too familiar of the cost that the Town had to endure in upholding our decision in an appeal to the Superior Court and the Appellate Court in the Guy Mauri appeal. In this case, the chances of success are too small to justify the expense of appeal.

While I support the small cells alternative, the facts of this case demonstrate to the Council how profoundly inappropriate and destructive placing a cell tower on a 1.99-acre lot, (in violation of no fewer than 6 Kent Zoning regulations) in the middle of our residential neighborhood would have be. BHRN expert R. Bruce Hunter provided a lengthy, detailed report on the wide-ranging enviroeconomic detriment to the residences and area surrounding the Bald Hill Road site. Reopening the Council's decision in full would renew the risk that the agency could place the facility on the Bald Hill Road site, creating the myriad of harms highlighted by R. Bruce Hunter, an expert who testified in the case on behalf of the Bald Hill Road Neighbors.

Therefore, I respectfully request that the Town not participate in any appeal of Docket No. 488 to the Superior Court due to the cost of appeal, the likelihood of success, and the chance that a complete remand would make a bad situation much worse.
