#### The Historic District Commission of Kent, CT Minutes of the Regular Meeting on July 13, 2020

#### Meeting Online via Zoom

The following members were present: James Vick, Chair; Ann (Dixie) Todd, John Worthington and Judith Warrick.

The meeting was called to order by James Vick at 7:15 p.m. The minutes of the meeting of December 9, 2019, were approved by acclamation.

#### **New Business**

- 1. Window replacement proposed for 107 Kent Cornwall Road Edward Sadtler, the owner, and his partner were present at the meeting. Edward had previously confirmed to James Vick that the 2 windows to be replaced are not visible from the road. James Vick reminded members that, in view of their being hidden from public view, these windows are not subject to the purview of the Commission. A motion to approve the application, having been duly made and seconded, was passed unanimously.
- 2. Modifications to Accessory Building proposed for 115 Kent Cornwall Road

Stuart Wurtzel and Patrizia von Brandenstein, the owners, were present at the meeting. Stuart elaborated on the application by saying that the modifications included not only removing the barn's siding and re-installing it to remove gaps between boards, but also applying a moisture barrier and insulation in the walls. The barn's appearance as seen from the road would be unchanged because any new siding required in the re-installation will be on the rear of the barn. A motion to approve the application, having been duly made and seconded, was passed unanimously.

3. Addition of a Sunroom proposed for 115 Kent Cornwall Road Jack Kinney, the contractor for the proposed project, was also present at the meeting. Jack elaborated on the application by saying that the addition's design and exterior materials are chosen to match the main part of the house in color, texture and overall appearance. The sunroom would be on the northwest side (rear) of the house and will be as inconspicuous as possible as seen from the road. A motion to approve the application, having been duly made and seconded, was passed unanimously.

There being no further business, the meeting was adjourned at 7:35 p.m. upon motion duly made and seconded.
