When asked how Mr. Mackin would know that the correct soil misture was being used, Mr. Mackin said that he trusts the contractor on the job. Ms. Werner expressed concern over the possibility of bringing invasives, such as phragmites, in with the planting soil and asked that Mr. Mackin keep that in the mind.
