Park & Recreation Commission Regular Meeting Monday, 02.07.2022 – 7:00p Meeting Minutes

**Call to order:** Lynn Harrington calls the meeting to order at 7:02 p.m.

## Ski & Snowboard Club


 Julia Neff reports that the program was successful and there is some outstanding work to be done on billing and refunds.

#### **New Business:**

# <u>Bartlett Tree Emerald Ash Borer Treatment</u>

- John Grant reminds the commission that this is a necessary service for the health of the trees at our parks and that the commission previously authorized the treatment to be performed.
- o Jared Kuczenski states that he will contact Bartlett to make sure the treatment is taken care of.

#### Camp Kent & Emory Park

- Lynn Harrington reports that she may have someone who is able to fix the pool and will check back in with the commission once she has further information.
- Lynn Harrington also reports that she will be working with Jared Kuczenski to bring back and improve Camp Kent.

## USTA "Tennis in the Parks" Program

- Julia Neff reports that she and Michael Perkins have been in touch with the USTA New England regarding this program.
- Julia Neff states that this will be a 6-week program with hour-long sessions one weekday per week from April 30th through June 18th. Grades 1 & 2 will run from 3:30p to 4:30p and grades 3 & 4 will run from 4:30p to 5:30p.



- Julia Neff also states that the program will be a Park & Rec "Fee Program" costing participants \$60.
- o Julia Neff also reports that the USTA will be providing coaches for the program.
- Motion to run the "Tennis in the Parks" program for the spring of 2022: Motion made by John Grant, carried unanimously.

## • Baseball & Softball

- Jared Kuczenski states that he will be reaching out to other communities in the area to determine the baseball and softball opportunities the currently exist.
- Jared Kuczenski also states that he will be working on creating a program palette that will address baseball and softball needs for children 3 years old through 18 years old with emphasis on developing a foundation to build off of for the future.
