Mr. Adams called the meeting to order at 4:30 p.m.

Mr. Adams made a motion to approve the minutes for the BOS Special Meeting on July 6, 2016, as submitted. Mr. VanValkenburg seconded the motion and the motion carried.

#### Tax Refunds:

Mr. Adams made a motion to approve the following tax refund:

Mr. VanValkenburg seconded the motion and the motion carried.

#### Approval of 2016/2017 Approved Vendor List:

Mr. Adams made a motion to approve the Approved Vendor List FY 2017, as submitted. Mr. VanValkenburg seconded the motion and the motion carried.

#### **Public Restroom:**

Mr. Adams stated that the Public Restroom Committee submitted the Restroom Bid Package to the state. DECD approved the bid package as submitted but stated that there are State requirements that need to be met. Mr. Parkin asked what the penalties are if the State requirements are not satisfied. Mr. Adams stated that he would inquire.

Mr. Parkin made a motion to approve the bid package, as submitted. Mr. VanValkenburg seconded the motion and the motion carried.

#### Audio/Video Taping of BOS meetings:

Mr. Parkin would like to propose to "live-stream" the BOS meetings on U-Tube to allow people to view the meeting if they cannot attend. He added that it would not be the "official" record of the meeting; the minutes would remain the "official " record. Mr. Parkin would like to have a survey go out from the BOS asking for the public's opinion on "live-streaming" the meetings. Mr. Adams stated that he will obtain legal opinion on the Town's liability and if the BOS would be self-obligating themselves to record "all" meetings. Mr. VanValkenburg stated that he is not in favor of video taping meetings. Ms. Hayes asked what could U-Tube do with the video once it is put on their domain? Mr. Adams stated he would look into that.

#### Traffic Flow:

Mr. Parkin noted that during the "Sidewalk Festival" the traffic light at the intersection of Route 7 and Route 341 had a long "wait time". He asked if there is a way to request the light timing be changed during special events. Mr. Osborne stated that the timing couldn't be changed on a temporary basis. He added that when the walkers hit the "walk" button, it slows down the street light rotation.

Mr. Parkin noted that there is one stop sign before Bulls Bridge and two coming from the New York side. He asked if it would be possible to have the stop signs changed to yield signs? Mr. Osborne stated that he would get the name of a traffic engineer to look at the signs.

#### **Public Letters:**

Mr. Parkin stated that the BOS should implement a policy to read all correspondences at meetings/hearings. He stated that he felt the letter from the Seaplane Pilots Association should have been read at the July 17, 2016 Town meeting. The BOS agreed that all letters related to a meeting should be read aloud at the meeting.

#### **Housatonic River Commission Alternate Appointment:**

Mr. Adams made a motion to appoint Steve Robey as an alternate on the Housatonic River Commission to an existing term that will expire on October 30, 2018. Mr. VanValkenburg seconded the motion and the motion carried.

#### Office Hours:

Mr. Parkin stated that several constituents have suggested that he, as the minority party selectman, hold office hours at Town Hall. He stated that he could not commit to regular hours but would notify the Town Clerk's office of his available hours weekly so they could be sent out weekly with the meeting schedules.

#### **American Tower:**

Mr. Adams stated he is waiting for updated documents from American Tower.

#### Salary review:

Mr. Adams stated that he believes the three selectmen are of the opinion that based on the survey he did and Mr. Parkin did, the Kent Town Hall employees are paid well in comparison to the other Towns. The three selectmen agreed. Mr. Adams presented a spreadsheet prepared by the treasurer reflecting total compensation for the benefited employees.

Mr. Adams stated that Treasurer Barbara Herbst submitted a written request (attached) to promote the treasurer's clerk to a Level II at the hourly rate of \$20.54. Mr. Parkin liked the "level" concept implemented by the treasurer but questioned the concept of mid-year salary increases.

Mr. VanValkenburg made a motion to approve the Treasurer's request to promote the treasurer's clerk to a Level II with an hourly rate of \$20.54. Mr. Adams seconded the motion for purposes discussion.

Mr. Adams stated that the Town Clerk has requested that the Assistant Town Clerk's salary be increased to \$19.75 per hour due to increased responsibilities. Mr. Adams stated that in the salary survey he provided, the hourly rate for the Assistant Town Clerk is based on two clerks and the one who is no longer here was paid a higher rate.

Mr. Parkin stated that the BOS has no previsions for merit-based raises. Mr. VanValkenburg stated that he recalled making an agreement with the treasurer that if she hired a clerk at the lower hourly rate, the salary could be increased when the clerk became more proficient. During discussion it was stated the BOS approved the budget, which included the salary increases requested. Mr. VanValkenburg withdrew the motion. Mr. Adams withdrew the second. Mr. Adams agreed to obtain additional information from the two department heads making the requests.

Mr. VanValkenburg made a motion to adjourn the meeting at 6:00 p.m. Mr. Adams seconded the motion and the motion carried.
