Bruce Adams called the Special Meeting to order at 1:00 p.m. Mrs. Williams asked Mr. Adams to read the meeting agenda, which he did.

**Treasurer's Clerks' Hourly Salaries:** Mr. Adams stated the Board of Selectmen March 3, 2015 approved the hiring of a new clerk to work in the Treasurer's Office at an hourly rate of \$17, effective Feb. 27, 2015. Treasurer Barbara Herbst said she increased the clerk's hourly rate to \$18.50 after a 90-day work period because the clerk then was more proficient in her duties. Mrs. Herbst said she did not realize the increase needs to be approved by the Board of Selectmen per the minutes of the March 3, 2015 meeting. Mrs. Herbst said she could add a column on the payroll manifest that shows employees' pay rates in response to a question by Mrs. Williams about how the clerk is paid (check or direct deposit). Linda B. Hall stated that the Selectmen took out of the Policy and Procedure Manual the \$1/hour increases for employees who take training, questioning how this increase is different. Mr. Adams said the Board of Selectmen would listen to department heads that come before the board with a salary request that is within the department's budget. Mr. Adams added that discussion of the Policy and Procedure Manual is not on this Special Meeting agenda. Mr. Adams made a motion to increase Joanne Matarese's hourly rate from \$17 to \$18.50, retroactive to May 1, 2015. Mr. Van Valkenburg seconded the motion, and the motion was approved unanimously.

Mr. Adams made a motion to set Marie Corsini's hourly rate of pay at \$19, which is the rate she was being paid previously, effective July 22, 2015. Mr. Van Valkenburg seconded the motion, and the motion was approved unanimously.

Approval of FY '16 Vendor List: Mrs. Herbst provided the board a list of vendors. Mr. Adams made a motion to approve the Town of Kent FY '16 Approved Vendor List submitted by the Treasurer and dated Aug. 5, 2015 (attached). Mrs. Williams seconded the motion, and the motion was approved unanimously. Mrs. Herbst requested three vendors be added to the Approved Vendor List. Mr. Adams made a motion to add Lenz Electric, Office Zilla and James Mauri to the Approved Vendor List. Mrs. Williams seconded the motion, and the motion was approved Vendor List. Mrs.
