Kent Sewer Commission Regular Meeting October 12, 2021 4:00 P.M. via Zoom

Members: Elissa Potts, Peter Gadiel, Jack Grant, Jack Nelson and Rick Osborne.

Also, present: Bart Clark, Debbie Devaux, Tim Good, Donna Hayes, Barbara Herbst, Wendy Murphy, Lyle Sommers, Paul Szymanski and Joanne Wasti.

Ms. Potts called the meeting to order at 4:04 p.m.

Amend agenda/approve agenda:

Peter Gadiel made a motion to approve the agenda, as submitted. Rick Osborne seconded the motion and the motion carried.

Approval of Minutes:

Peter Gadiel made a motion to approve the Sewer Commission Regular meeting minutes of September 14, 2021, as submitted. John Grant seconded the motion and the motion carried.

227 North Main Street:

Paul Szymanski of Arthur H. Howland & Associates. P.C. attended the meeting representing the developers for the proposed project at 227 North Main Street. Paul wrote a letter dated September 8, 2021 (attached). Elissa Potts responded via email on October 6, 2021 (attached) and October 7, 2021(attached) via letter that was emailed. Paul noted that the 227 North Main Street is in the future sewer service area, same as the Maple Street Ext. which is served by the sewer system as of seven or eight years ago. Paul asked if he could review each numbered item on the October 8th letter:

1. In my letter of requested, I noted the anticipated the maximum daily usage would be 7,800 per day in that it was estimated on 4-bedroom homes. If there is an issue, they could reduce some to 3 bedrooms so that it falls under 7,000 a day. The proposal included a main not a lateral, which should be able to accommodate 7,800, but happy to reduce it.

Elissa Potts noted that if you are in the 7,800 range, it requires approve from CT DEEP.

2. Paul went to the Town Clerk today and could not find the regulations and requested a copy.

Elissa provided a copy of the Town of Kent Sewer service area as of September 2009 and it does show 227 North Main Street in the future sewer service area, the same as Maple Street Ext. which is no serviced by public sewer.

Elissa emailed a copy of the regulations to Paul. It was confirmed that they were sent to an invalid email address.

Bart confirmed the availability has to do with the direct connection without extension. If you are more than a certain distance away from the sewer, then you have to request an extension. Which you are in the process of getting. That's not meant to say that you can't extend the sewers means that you have to extend the sewers in order to service to gain service for your property.

Paul confirmed that he is on the right path where he is preliminarily discussing and acknowledged that he will be extending the public sewer to in front of the property and then once that is done, comment 2 is no longer applicable. Elissa and Bart agreed.

- 3. Paul noted this item was just a clarification that the commission has no plans to extend the sewer system north to service this property which he is aware of and acknowledge that.
- 4. Paul noted that only one developer financing a sewer extension for property outside of the service area has been permitted. That being the Kent healthcare facility. Upon a determination that the sewer extension serves public interest by providing sewer availability to multiple properties with marginal or failing septic systems. So based on Bart's comments, it would appear that if the they install the sewer extension at their expense it would be possible.

Elissa confirmed it would be possible.. She noted that Maple Street Ext. was done because it is the only area deemed industrial and the hope was to bring some sort of small industry into Kent.

- 5. Paul noted that he understands that there will be connection fees associated with the proposal.
- 6. Paul confirmed that they do want to be served by the sewer system.
- 7. Paul stated it was a personal comment and not applicable.

"An equal opportunity employer and service provider" Sewer Commission Regular Meeting Minutes, October 12, 2021 Page 2 Elissa confirmed that Paul will have to complete an application and there are a couple of guidelines that will need to be followed, including creating an escrow account to pay for the commission's costs.

Paul confirmed that at this time he looking for a confirmation that the sewer plant has the capacity and that it is possible for them to extend the public sewer, at their expense, noting the laundry list of items that will still have to be completed.

Elissa confirmed that Paul is headed in the right direction and she will get him the necessary applications and regulations.

Elissa Potts stated that the regulations were approved on March 9, 2020 but they were not attached to the minutes. Attorney Jeff Sienkiewicz is sending a new clean copy of the regulation to be approved and attached to the next Sewer Commission meeting minutes and uploaded on the Town website.

In response to your letter of September 8, 2021, please be advised as follows:

- 1. The Kent municipal sewer plant appears to have capacity to treat additional sewer flow of 7,800 gallons per day.
- 2. The premises known as 227 North Main Street are not within the Town of Kent sewer service area. As such, sewer service is not considered "available" to this property. See Regulations, Section 2.01(B). The Sewer Commission has no plans to extend the sewer system north to serve this property.

3. The Regulations do not provide for developer financed sewer extensions as proposed. Only one developer financed sewer extension for property outside of the service area has been permitted (the Kent) upon a determination that the sewer extension served the public interest by providing sewer availability to multiple properties with marginal or failing septic systems.

I am writing this letter to express my concerns about the proposed development at 227 North Main Street. I would appreciate your reading this letter into the minutes at the October 14, 2021 Planning and Zoning meeting.

- 1. The Kent Sewer plant would be able to accept and process the additional 7,800 estimated gallons per day from the proposed development; however it exceeds the allowed 7,000 gallons per day per lateral as permitted by the CT DEEP.
- 227 North Main Street is not within the Town of Kent Sewer service area.
 As such, sewer service is not considered "available" to this property. See Regulations, Section 2.01(B)

Section 2 Orders to Connect

Section 2.1 Connection of Existing Property and Developments

- B. Sewers are considered available when: there is sufficient capacity in the Sewer Treatment Plant and the Sewer Collection system, and the property is within the Sewer Service Area as shown on the latest version of the map as maintained by the Sewer Commission.

- 3. At present, the Kent Sewer Commission has no plans to extend the sewer system north to serve this property
- 4. The Kent Sewer Regulations do not provide for the developer financed sewer extensions as proposed. Only one developer financed sewer extension for property outside of the service area has been permitted (The Kent Health Care Facility) upon a determination that the sewer extension served the public interest by providing sewer availability to multiple properties with marginal or failing septic systems
- 5. The Kent Sewer Commission has begun the process to upgrade the plant by designing and planning to install a second aeration tank to meet the capacity for future growth. This expansion is a \$1,000,000.00 plus project that will take several years to design, get all the necessary permits and approvals, acquire adequate financing and complete due to the Pandemic.
- 6. If the property owner opts to install septic systems for each building, he would be limited to 10 structures.
- 7. Lastly, on a personal note, I find it stunning that the Planning and Zoning Board is disregarding all the hard work from people like Barbara Lasch, who worked tirelessly with Planning and Zoning to carefully protect the ridge line at the Saddle Ridge development. I do not understand the strong hold Paul Szymanki seems to have on this project. Please do the right thing. This development as presently designed, will change Kent forever.
