

# KENT TRANSFER STATION PERMIT APPLICATION

DEAR TRANSFER STATION USER:

- USE OF THE TRANSFER STATION IS BY PERMIT ONLY.
- SHARING A PERMIT **IS NOT** ALLOWED.
- PERMITEE IS ENTITLED TO DELIVER HOUSEHOLD WASTE FROM ONLY ONE KENT HOUSEHOLD.
- EVERY HOUSEHOLD **MUST** RECYCLE.
- PERMITS ARE GOOD FOR THE FISCAL YEAR, JULY 1 THROUGH JUNE 30, OF EACH YEAR.
- THE COST FOR EACH PERMIT IS \$150.
- THERE IS A \$20 SENIOR DISCOUNT AVAILABLE TO RESIDENTS 65 YEARS OF AGE OR OLDER. (\$130).
- PERMITS CAN BE PURCHASED AT THE SELECTMAN'S OFFICE DURING NORMAL BUSINESS HOURS:  
MONDAY THROUGH FRIDAY 9:00 AM – NOON AND 1:00 PM – 4:00 PM
- OR YOU MAY MAIL A COMPLETED APPLICATION, A CHECK AND A **SELF ADDRESSED STAMPED ENVELOPE** TO:

- PLEASE MAKE CHECKS PAYABLE TO: TOWN OF KENT
- THE PERMIT TAG SHOULD HANG ON THE VEHICLE'S REARVIEW MIRROR TO BE VISIBLE BY THE STATION ATTENDANT.
- THERE IS A **\$25 FEE** TO REPLACE LOST OR DAMAGED TAGS.
- THE ATTENDANT IS THERE TO SUPERVISE THE OPERATION OF THE TRANSFER STATION.
- **BULKY WASTE IS AVAILABLE EVERY WEEKEND – THERE ARE ADDITIONAL FEES.**
- THE TRANSFER STATION IS LOCATED ON MAPLE STREET (ROUTE 341 EAST) AND USES THE SAME ENTERANCE AS THE KENT.
- THE TRANSFER STATION HOURS ARE:  
SATURDAY AND SUNDAY 8:00 AM – 3:30 PM  
GATE CLOSSES AT 3:15 PM
