3. READING AND APPROVAL OF MINUTES:

3.A. Regular Meeting Minutes, November 14, 2017

Chair Lady Corsell requested a change to the minutes that reflected the vote was 2 in favor and 1 abstention, regarding the submission of App. #013-16.

There was further discussion on this application that centered on the fact that the original application was presented by Paul Syzmanski at a time when the property in question was under contract to be sold. At that time, ARB members approved the application with changes, namely that the fence along Maple Street would be omitted. The new owner(s) went forward with a fence, and landscaping contrary to what the Board had approved. This action by the representatives of the new owner(s) was based on approvals from Planning and Zoning.

Furthermore, member John Milnes Baker questioned the validity of the November 14th meeting based on the fact that he was not present, that is, the meeting took place without the presence of an architect.

This led to a request by the attending members that the language of the present rules and regulations be reviewed, and possibly changed, so that in future meetings, at least one architect would have to be
