#### Annual Budget Hearing on Proposed 2023-2024 Budget

Comments from the public

- a. Chris Garrity-Thanked Barbara Herbst for her work on preparing the budget for everyone. It looks great! Concerned about the mill rate.
- b. Debbie Deveaux- mill rate is high. Suggested cutting the 2nd park and rec position
- c. Marty Lindenmayer-well prepared budget. Combine wages, salaries and benefits? Questioned why ARPA fund distributions are included in the grants section. Treasurer Herbst explained they are listed as a reference but not included in the budget.
- d. Ellen Gutierrez- Spoke in favor of the BOE budget and opposes any cuts to the KCS budget
- e. Lynn Harrington-suggested instead of moving \$400,000 from unassigned funds, only move \$200,000 and save the other \$200,000 for next year after the property valuations. Supports increases for

- dept heads. Spoke on issues with Park and Rec dept. Questioned enrollment decline in school.
- f. Scott Tabucco-explained the how they came up with the BOE budget
- g. Tom Ryan-spoke on BOE budget. Mr Wright replied the BOF does have support the school
- h. Elizabeth Bernard-spoke in favor of Park and Rec programming and the need for another position in Park and Rec (asst to the director)
- i. Chris Garrity-spoke on Park and Rec concerns
- j. Tom Ryan-spoke about the difficulties getting volunteers to assist with Park and Rec programs
- k. Jean Speck- spoke about Mill Rate. 21 towns in the COG. 14 of them have a higher Mill Rate, 6 have a lower Mill Rate. Kent is on the lower end of the middle of the 21 towns. 32.46 is the highest rate in the State and Salisbury has the lowest at 11. She also stressed the need for a full time asst to the Park and Rec director.
- I. Thomas Ford-is the after school program director. Spoke about the children and his love for the kids he serves. Has been in his position for roughly 1 year. Spoke very highly of Jared's accomplishments so far as Park and Rec director.
- m. Debbie Deveaux- reiterated that the asst to Park and Rec director should be part time not full time
