Call to order:

Marty Lindenmayer called the meeting to order at 12:01 p.m.

Public Comment on agenda items:

Budget discussions:

Second Trooper request from Andrew Ocif:

The Board of Selectmen agreed:

- To research speed signs with ticketing capabilities for speed enforcement.
- To add additional overtime to the budget.

Lynn Worthington made a motion:

For Fiscal Year 25, Police Protection be funded at \$187,271, which includes overtime. Glenn Sanchez seconded the motion and the motion carried.

LCD:

Marty Lindenmayer:

Increase due to the hiring of an additional dispatcher.

Emergency Management:

Marty Lindenmayer:

Budget reduced from \$12,500 to \$7,500.

Lynn Worthington:

Requested an updated document to support the reduced budget.

Lynn Worthington made a motion:

To change line 260, Emergency Management for Fiscal Year 25 to \$5,000.

Park and Rec:

The Board discussed the request for a fulltime Recreation Leader.

Rufus deRham:

- The commission has been talking about a fulltime position for years.
- The director is doing work that is not at the executive level.

Matt Busse:

Reviewed Park and Rec's staffing needs, and requested an additional \$2,000 for hourly employees.

Lynn Worthington made a motion:

To adjust the lines to the budget to make allowance for a full time Recreation Leader, the health line would be \$60,314, the pension line would be \$5,623, and social security would be \$6,485.

No second on the motion. The motion fails.

Marty Lindenmayer made a motion:

To accept the Park and Rec Director's salary at \$63,000, the hourly employees at \$37,781.60.

Glenn Sanchez seconded the motion. Marty Lindenmayer and Glenn Sanchez voted yes. Lynn Worthington voted no. The motion carried.

Transfer Station:

Salary increased declined until the July review.

EMS & KVFD:

- No one from EMS or KVFD attended the meeting.
- The BoS requested the following information:
 - Number of calls
 - Number of billable calls
 - Number of shifts covered by volunteers
 - Number of shifts covered by paid staff

Tax Collector:

Debbie Devaux:

Increased assistant line to 15 hours per week to satisfy the certification requirement.

Contingency:

BoS agreed to increase the line to \$30,000, per the treasurer's recommendation.

To approve the Board of Selectmen Budget for fiscal year 25 of \$5,149,272. Glenn Sanchez seconded the motion and the motion carried.
