## Town Hall large meeting room video conference system update:

Jean Speck stated she has been back and forth with town attorney on the requirements for hybrid meetings. She added it appears the technology needed for hybrid meetings will not be covered under ARPA funds. Chris Garrity suggested waiting, let someone else be the first one. He recommended tabling the item.

#### Senior Center programming proposal update:

Leah Pullaro stated the following:

- Submitted a budget proposal for the proposed Senior Center programming (attached). She noted that the total is incorrect, the total should be \$7,121.
- The \$4,021 is for the Social Services Director/Senior Program Co-Ordinator, not budgeted.
- The \$4,021 is comprised of approximately 4 hours per week which would put the Social Services Director over 30 hours per week (fulltime).
- The Social Services Assistant is budgeted for 4 hours per week to implement the programs.
- Park and Rec to clarify their role in senior center activities Ed Matson to discuss with Park and Rec Commission as they review the Park and Rec Director job description.
- Outline the responsibilities of the Senior Center Co-Ordinator: set-up schedule, researching programs, co-ordinate with other departments to set-up senior programs.
- Timeline to start programing October 1, 2021.

Chris Garrity noted making the Social Services Director fulltime is a budgetary issue.

#### Peddler Permit - food trucks:

Jean Speck provided the Food Truck Ordinances for Sharon and North Canaan (attached). Jean Speck agreed to obtain the guidelines from Torrington Area Health and State of Connecticut Department of Transportation for food trucks. Chris Garrity noted the Noise and Traffic Committee might want to consider the safety and health concerns.

#### **Policy and Procedure Manual:**

Hiring Policy – Department Head input:

Jean Speck gathered the feedback from the department heads and will take that Information and rewrite the policy. She will send a draft to the department heads for feedback prior to sending to the BoS for approval.

#### Review Manual update:

Jean Speck noted she is still pulling apart the manual.

#### Juneteenth Federal Holiday:

The Board of Selectmen discussed adding Juneteenth to the paid days off list. Ed Matson stated the State is considering taking away Columbus Day and adding Juneteenth. He added he is not comfortable making a decision until the State makes a decision.

Jean Speck stated the union contract has been signed based on the discussion in the last executive session. The other Board members have not seen the final contract. Copies of the contract will be sent to the board and a special meeting should be scheduled to approve the contract.

I would like this letter to be read at your August 17, 2021 meeting and recorded into your minutes.

On December 11, 2020, I wrote to you and expressed my concerns regarding any Permanent Food Truck Permit for Kent.

I remain vehemently opposed to a Food Truck Permit. I believe that if such a permit were granted, it would be devastating to the town of Kent.

- 1. You would destroy the look and feel of Kent as the gateway to the Northwest corner.
- 2. There are at present no less than 17 Brick and Mortar Food Establishments in Kent, one "Grandfathered" Food Truck, owned by Chris Della Riva, and more food establishments to open in the future. Each business pays a MORTGAGE or RENT, and TAXES, and is subject to ADA requirements, parking regulations, ARB rules and must provide rest rooms for their patrons.
- 3. Food trucks would just parachute in, pay a nominal fee for a Permit, and drive off at the end of the day. They do not have the same overhead and expenses that all of the local food businesses have to deal with on a daily, monthly and yearly basis.
- 4. Parking...where would they park...on State Highway Route 7, or on private property?

In my opinion, allowing any food trucks to operate here would not enhance the town of Kent. Ultimately, one truck would lead to more, and then the town would be subject to other pop up businesses that do not have to adhere to the same rules and regulations the local brick and mortar businesses do. It would be the beginning of the end for the charm and allure of Kent, CT.

Why does this conversation continue? Avoiding junking up Main Street with Food Trucks should be a no brainer. You need to care about the long term view for Kent.

A copy of the Joint Resolution was submitted to the Mayor's Office in the Town of New Milford, and he has put it on the agenda for the Council Meeting August 9th. I'll be happy to come up to the Kent Selectmen meeting prepared with a very brief statement (assuming they will have already read the Resolution) and to take any questions.

As I mentioned, there are two public programs planned for Saturday, October 23rd. There are also two private events for the Holloway family.

- 10:00-11:00 am. New Milford Historical Society & Museum, Aspetuck Road, downtown New Milford. The program will include a host welcome, and a reading of the resolution by several NM townsfolk, and then would Mayor Bass do us the honor of saying a few words for the occasion and lead us in a moment of silence? ~ I am hoping there will be time for folks to share memories at the end. The Museum may bring out a display of Florence's wooden cross from her grave (when they laid a headstone there in the '60s) &/or her famous black dress but nothing extensive, as I believe they have another exhibit running.
- 4:00-5:00 pm. St. Michael's Chapel & Cemetery, South Kent School, Kent. The program will include a host welcome and a reading of the Joint Resolution by several Kent townsfolk. This will be followed by an Evening Service in Florence's Honor conducted by St. Michael's Pastor Steve Stolz, which may include a procession to the gravesite (weather permitting?). It would be great if someone representing the Town of Kent could join us and perhaps say a few words.

I'm so glad we will have the chance to tell the whole of Florence's story in Litchfield County, and that we have the time to develop the programs and give this bit of local history adequate publicity. I appreciate your help in making this happen.

## Proposal for Resolution Honoring Florence Chandler Maybrick for Remembrance on October 23, 2021

- WHEREAS, in 1917, communities in the Town of New Milford, and the Town of Kent, Connecticut, welcomed a poor stranger who went by the name of Mrs. Florence Chandler, a small, well-bred lady with a mysterious past, ostensibly for employment in Gaylordsville at the poultry farm of Miss Henrietta Banwell; and
- WHEREAS, despite Mrs. Chandler and the chickens at the farm taking an instant dislike to the other, this lady decided to leave the job but stay in the bucolic Gaylordsville neighborhood bordering New Milford and Kent; and
- WHEREAS, in 1919 a benefactor of Mrs. Chandler anonymously paid for her to purchase a small plot of land on the eastern side of Long Mountain, amounting to about one-third of an acre, sited on the remote road from Gaylordsville to South Kent, a historic and scenic "highway" known now as Old Stone Road, before which it was known locally in both New Milford and Kent as "Chandler Road"; and
- WHEREAS, in 1920 the benefactor paid the C. M. Beach Company to build a three-room 12 x 20-foot bungalow for Mrs. Chandler on the property featuring three cat doors and a 6-foot porch with a scenic view looking south over the Upper Housatonic Valley; and
- WHEREAS, for two decades Florence Chandler lived as a recluse in her cozy house with a burgeoning clowder of cats, which she called her "children of the mountain," earning herself the moniker "The Cat Woman" or "The Cat Lady" from the local children; and
- WHEREAS, in 1923 at the north terminus of Old Stone Road located in the Town of Kent, Mr. Samuel Bartlett and Mr. Richard Cuyler established South Kent School, modeled on the Kent School from which the two founders were alumni, soon after which the new school housemother, Sister Clara Dulon, extended a selfless hand of friendship to Mrs. Chandler; and
- WHEREAS, the South Kent School staff, faculty, and especially the students became endeared to old Mrs. Chandler, and along with her Gaylordsville

- neighbors selflessly provided her substantial physical and spiritual support for the rest of her life; and
- WHEREAS, in 1933 Sister Dulon died and was interred near the school chapel known now as St. Michael's on the South Kent School campus, prompting Mrs. Chandler to request permission to be buried near her dear friend, a wish granted by South Kent School cofounder and headmaster Mr. Samuel Bartlett; and
- WHEREAS, after the death of her friend Clara, Mrs. Chandler continued to associate with South Kent School staff and students, who along with her Gaylordsville neighbors supported her with provisions of food, water, firewood, and clothing through the Great Depression until her dying day; and
- WHEREAS, in her old age Mrs. Chandler became reclusive and avoided meeting adults on her once-daily walks along the road, indeed which at some point was informally known to locals as Chandler Road, but delighted in the company of South Kent School students when they came to see her; and
- WHEREAS, on the morning of October 23, 1941, Old Mrs. Chandler was found dead in her home by neighbor Mr. Howard "Pop" Conkrite, and was buried next to Miss Dulon three days later near the chapel at South Kent School, attended by more than 60 school faculty, staff, and students, and Gaylordsville neighbors; and
- WHEREAS, the day after her death, on the 24th of October, 1941, Florence Chandler Maybrick's obituary ran at the top of the front page of the *New York Times*, reporting her death in Gaylordsville, revealing her hidden identity as the defendant in a famous 1889 murder trial in Liverpool and recalling her amazing life story:
- WHEREIN Florence, a young lady born in Mobile, Alabama during the Civil War from a prominent American family, married James Maybrick, an older British cotton broker with whom she had two children, living in Liverpool, before discovering her husband's second "wife," with whom he had five children, as well as his longtime addiction to arsenic and strychnine powders; and

- WHEREAS, in 1889 when James Maybrick abruptly died from a stomach disorder, his brother Michael unjustly accused Florence of poisoning her husband, then led the charge to have her arrested, tried, convicted, and sentenced to hang for the murder; and
- WHEREAS, subsequent evidence proving Florence's innocence and exonerating her from this crime indicates that James was killed by his brother Michael, believed to be psychopath murderer Jack the Ripper, who with his brother Edwin poisoned James and framed Florence for the murder of her husband, subsequently confiscating her two young children and her entire estate; and
- WHEREAS, the imprisonment and trial of Florence Chandler Maybrick stole her rights, manipulated evidence, suppressed witnesses, and violated proper and fair legal proceedings, presided by a mentally debilitated, opium-smoking, misogynistic judge, and convicted in less than an hour by a jury of laymen confused by a preponderance of conflicting medical evidence yet willing to hang the victim; and
- WHEREAS, while a gallows was built outside Mrs. Maybrick's cell, the injustice of her arrest and trial created a public uproar not just in Liverpool but on both sides of the Atlantic, making her arrest and trial a cause célèbre, prompting urgent diplomatic appeals by Vice President Levi P. Morton and the wives of President Benjamin Harrison's entire Cabinet; and
- WHEREAS, under intense public pressure, Queen Elizabeth allowed the Home Secretary of Scotland Yard to commute Florence Maybrick's capital sentence to life imprisonment as punishment for a different crime with which she was never charged or duly convicted; and
- WHEREAS, while Florence served her term of fifteen years in British prisons, subject to long periods of solitary confinement and hard labor, her supporters helped to bring reforms to British jurisprudence such as the creation of an appellate court for capital punishment, and joined together in the early women's suffrage movements of both countries; and
- WHEREAS, in 1904 Florence was released from prison and returned to the States to find many supporters, to write a book entitled *My Fifteen Lost Years*, and to manage a successful tour on the lecture circuit, advocating for prison reform and always declaring herself innocent of the murder of her husband; and

- WHEREAS, after public interest in her case waned, she became indigent and recovered at the Salvation Army in Chicago; and
- WHEREAS, in 1917 Florence wrote to playwright Cora Griffin in Brookfield, asking her friend if she knew of any employment for her, and Miss Griffin arranged the job at Miss Banwell's chicken farm in Gaylordsville; and
- WHEREAS, Florence came to our area using her maiden name as a cover story and found that she could live her life without the stigma of being an ex-convict here in the relatively remote hills of the Northern Housatonic Valley among the Yankee farmer families who mostly minded their own business; and
- WHEREAS, although Florence Maybrick lived anonymously as Mrs. Chandler in New Milford for a quarter-century, several of her neighbors in New Milford as well as in Kent discovered or guessed her hidden identity and kept her secret secure, while for two decades ensuring that she should never go without food, water, milk for her many cats, or medical attention; and
- WHEREAS, the 23rd of October, 2021, marks the 80th anniversary of the end of the tragic life of Florence Chandler Maybrick, an event which unexpectedly during the advent of the Second World War put both Gaylordsville and South Kent on the top of the front page of the New York *Times* for the first and only time, thus bringing the world's attention to our great towns; and
- WHEREAS, citizens of the Town of New Milford as well as citizens of the Town of Kent, in coordination with the New Milford Historical Society, the Kent Historical Society, the Gaylordsville Historical Society, South Kent School, St. Michael's Chapel at South Kent School, and with the blessings of the Holloway family who now own Florence's land on Old Stone Road, together wish to honor the memory of the life of Florence Elizabeth Chandler Maybrick on the 80th anniversary of her death,
- THEREFORE, be it resolved that Saturday, the 23rd of October, 2021, be heretofore known as "Florence Chandler Maybrick Day" in the Town of New Milford and the Town of Kent in the Great State of Connecticut.

Florence's Alabama background; her husband, James, cotton merchant & arsenic addict; & his brother, Michael Maybrick a/k/a Jack the Ripper

Accused American murderer Florence Maybrick (1862 – 1941), was born Florence Elizabeth Chandler, in Mobile, Ala., daughter of a one-time mayor there. She met British cotton broker James Maybrick in 1881 aboard a transatlantic ship and were married in London soon after, settling down in Aigburth, a Liverpool suburb, in Battlecrease House.

Florence entered local society life with James, who gave her two children, a boy and a girl. Maybrick also provided support for five children from another woman. Despite their age difference, together with her wealthy husband, she charmed Victorian Liverpool.

James's brother, Michael Maybrick, was a famous songwriter and charismatic singer who for more than a century nobody knew was the notorious British psychopath known as *Jack the Ripper*. James and Michael were both Freemasons, whose cultish traditional vows included silent complicity to protect one's Mason bros, even in cases of purjury or murder.









# PROCLAMATION HONORING Florence Chandler Maybrick

WHEREAS, in 1917, communities in the Towns of Kent and New Milford, in the Great State of Connecticut, welcomed a poor stranger who went by the name of Mrs. Florence Chandler. A small, well-bred lady with a mysterious past, Mrs. Chandler settled down and lived in a Gaylordsville neighborhood bordering New Milford and Kent; and

WHEREAS, in 1923 at the top of Old Stone Road in Kent, Mr. Samuel Bartlett and Mr. Richard Culler established South Kent School, modeled on the Kent School from which the two founders were alumni, soon after which the new school housemother, Sister Clara Dulon, extended a selfless hand of friendship to Mrs. Chandler. Sister Dulon died in 1933 and was interred near the school chapel known now as St. Michael's on the South Kent School campus, prompting Mrs. Chandler to request permission to be buried near her dear friend, a wish granted by headmaster Mr. Samuel Bartlett; and

WHEREAS, on the morning of October 23, 1941, Mrs. Chandler was found dead at age 71 in her home by her neighbor and was buried next to Miss Dulon near the chapel at South Kent School. The day after her death, Florence Chandler Maybrick's obituary ran at the top of the front page of the New York Times with a South Kent dateline, reporting her death in Gaylordsville, revealing her hidden identity as the defendant in a famous 1889 murder trial in Liverpool and recalling her amazing life story; and

WHEREAS, Florence, a young lady born in Mobile, Alabama during the Civil War from a prominent American family, married James Maybrick, an older British cotton broker with whom she had two children, living in Liverpool, before discovering her husband's second "wife," with whom he had five children, as well as his longtime addiction to arsenic and strychnine powders. In April 1889 when James Maybrick abruptly died from a stomach disorder, his brother Michael unjustly accused Florence of poisoning her husband, then led the charge to have her arrested, tried, convicted, and sentenced to hang for the murder; and

WHEREAS, subsequent substantial evidence proving Florence's innocence and exonerating her from this crime indicates that James was killed by his brother Michael, believed to be psychopath murderer Jack the Ripper, who with his brother Edwin poisoned James and framed Florence for the murder of her husband, subsequently confiscating her two young children and her entire estate; and

WHEREAS, while a gallows was built outside Mrs. Maybrick's cell, the injustice of her arrest and trial created a public uproar not just in Liverpool but on both sides of the Atlantic, prompting urgent diplomatic appeals by Vice President Levi P. Morton and the wives of President Benjamin Harrison's entire Cabinet; and

WHEREAS, in 1904 Florence was released from prison and returned to the States to find many supporters, to write a book entitled My Fifteen Lost Years, and to manage a successful tour on the lecture circuit, advocating for prison reform and always declaring herself innocent of the murder of her husband; after which she chose to escape the notoriety of the name Maybrick by living in Southern Litchfield County under ther maiden name, and

WHEREAS, the 23rd of October, 2021, marks the 80th anniversary of the end of the tragic life of Florence Chandler Maybrick, an event which unexpectedly during the advent of the Second World War put both South Kent in Kent and Gaylordsville in New Milford atop the front page of the New York Times for the first and only time, thus bringing the world's attention to our great towns.

NOW, THEREFORE, WE, Selectmen of the Town of Kent in the great state of Connecticut, do hereby proclaim Saturday, October 23rd, 2021, be known as "Florence Chandler Maybrick Day."

Definition of a Food Truck

Any vehicle, trailer or mobile unit used for serving any type of prepared food or drink. Food Trucks are labelled as "point of sale", catering an event would not be considered a Food Truck but would still have to submit to health department inspections and comply with all applicable health regulations of Sharon's Health Department and the State of Connecticut Health Code.

#### Section 2

- 1. Any Food Truck must have a current license from the Town's Health Department authority.
- 2. The following must be submitted by vendor prior to issuing a permit:
  - a. Valid food safety certificate, unexpired
  - b. If not pursuing a year-round license with Sharon, vendor must present an annual permit from another Health Department
  - c. A copy of their most recent inspection
  - d. Water test from within the last year if they are using private well water as their water source on their truck
  - e. A pre-operational inspection must be conducted by the Sharon Health Department prior to serving food to the public
- 3. A Food Truck Must get a permit from the Selectmen's office. Permit must list location with a map of Food Truck placement on property, date and hours of operation, permission from land/business owner and permission from any "Brick and Mortar" food businesses if within said 50'. 50' will be measured from the main entrance of said "Brick and Mortar" businesses. Land/business owner shall provide indoor, fixed toilet and hand washing facilities for the Food Truck employees. Portable toilets shall not be permitted.
- 4. The permission from the host land/business owner should also be in writing and have a commencement and termination date stated.
- 5. The host of a Food Truck is the land/business owner that issues permission to the Food Truck to use that entity's/person's premises for Food Truck vending.
- 6. The host premises or business owner who issued permission to the Food Truck operator shall be bound by the terms and conditions of this Ordinance and may revoke permission at any time for a Food Truck operator's violation of any Ordinance term. In such event the Municipal Food Truck Permit shall be automatically revoked for that host site.
- 7. Permits are not transferable.

- 8. No Food Truck may operate on town or state-owned property unless it is for a Town sponsored event or a non-profit event with permission from the Board of Selectmen.
- 9. Food Trucks may not be stored on host property. The only exception would be for Food Trucks used in Town sponsored events.
- 10. Food Trucks will not have "amplified" speakers for music or hawking. Low sound level music may be played within the Food Truck.
- 11. Food Trucks are responsible for providing trash receptacles and are also responsible for removing all their own trash daily.
- 12. All Food Trucks must pay a fee, which is determined by the length of time in accordance with the fee schedule below.
- 13. No Food Truck shall operate within 50' of any "Brick and Mortar" food business during that business's regular operating hours without written permission from said business owner.
- 14. Any Food Truck not registered in Sharon shall be limited to a maximum of 36 single day permits in one calendar year. Food Trucks registered in Sharon will have no limits as to the amount of days of operation but must obtain a permit for each day. Permits for multiple days in a row or multiple dates can be pulled at the same time. Any out of Town Food Truck requesting more day permits than stated above would have to come to a Board of Selectman monthly meeting and explain why they would seek permission to have more dates. Any decision made by the Board of Selectmen shall be in its sole discretion and judgment and shall be final.
- 15. Any Food Truck operating without a day permit would be fined \$100 for the 1<sup>st</sup> offense, \$200 for second offense and on a third offense permission to operate in Sharon would be denied for (1) calendar year from date of most recent offense.
- 16. Hours of operation will be no earlier than 7 AM and no later than 10 PM.
- 17. Any complaints about a Food Truck operation will be brought to the Board of Selectmen. Including but not limited to noise, smell, appearance, or any other issues and/or complaint that may arise. At such time the Board of Selectmen may, in its sole discretion and judgment, terminate said Food Truck's ability to obtain any additional permits within that calendar year. In its discretion, the Board of Selectmen could determine that the said Food Truck would have to appear in front of the Board of Selectmen before being allowed to operate in town again.
- 18. In the event of limited space, permits shall be issued on a first come, first serve basis.
- 19. Temporary Signage, such as a sandwich sign, temporary tables and chairs, are permitted only in proximity of the Food Truck.

#### Section 3

Fee Schedule

All Food Trucks shall pay a \$10 a day permit fee.

A fee of \$100 would cover an Annual Permit for one year from the date the permit is issued for those Food Trucks registered in Sharon. All other rules still apply.

A fee of \$250 would cover an Annual Permit for one year from the date the permit is issued for those Food Trucks not registered in Sharon. All other rules still apply.

If approval to operate more than the (12) approved permits day fees would be follows \$50 a day Monday-Thursday; \$75 a day Friday-Sunday

Food Trucks registered in North Canaan =\$5 a day Monday-Thursday or \$10 for the 4 days; \$5 a day Friday-Sunday or \$10 for the 3 days. A fee of \$150 would cover one year from the date the permit fee is paid. All other rules still apply.

In addition to these 12 days, the First Selectman may close Town Hall for any reason, the most common of which is a dangerous weather condition.

#### Fair Treatment

The First Selectman and every Department Head are encouraged to consider an unusual circumstance that an Employee faces where the policies set forth herein could be temporarily amended in a negotiated agreement that fairly exchanges Time Off for other compensation. However, any Employee seeking a recurring or "standing" exception to the policies set forth herein must apply to the Board of Selectmen for such a waiver. See Appendix I. All such policy waivers granted shall be a matter of public record and shall terminate the following June 30<sup>th</sup>. The Employee may apply for and the Board of Selectmen may grant a new waiver any time after July 1<sup>st</sup> of a succeeding fiscal year.

## **PROCLAMATION**

African Americans enslaved in Galveston, Texas first learned of their freedom on June 19, 1865, two and one-half years after the Emancipation Proclamation issued by President Abraham Lincoln became effective.

Since that time, June 19th has become known as "Juneteenth," and is recognized as the oldest known celebration of the end of slavery in the United States.

Since 1865, the observance of June 19th as Emancipation Day has spread across the United States and beyond.

Juneteenth not only commemorates African American freedom, but it also emphasizes education, self-improvement and the myriad achievements of the African American community. It is marked with public readings of the Emancipation Proclamation and celebrations with family and friends.

Throughout the State of Connecticut, many organizations will host Juneteenth Celebrations, including parades and cultural activities with entertainment and food.

Here in Connecticut, we have worked to attempt to correct the wrongs of the past in working with the General Assembly on policies aimed at bringing equity to all of our communities.

Slavery is a stain on the American conscience, and it is incumbent upon all of us to learn from the past, listen to our neighbors, and work to forge a better and more just future for our children and grandchildren.

I also applaud the 117<sup>th</sup> Congress of the United States of America for voting in a bipartisan fashion to make Juneteenth a Federal holiday, allowing all across our country to recognize the significance and history of this day.

I would also like to thank President Biden for signing the Juneteenth National Independence Day Act into law.

THEREFORE, in recognition of the 156<sup>th</sup> anniversary of the emancipation of all people who were enslaved in the United States of America, and in accordance with the laws of the State of Connecticut, I hereby proclaim June 19, 2021, to be

#### JUNETEENTH DAY

in the State of Connecticut and encourage all our citizens to recognize the many significant contributions of Connecticut's African American community but also to reflect on Connecticut's incomplete journey toward racial equity.

Given under my hand and seal of the State at the Capitol, in Hartford, nineteenth day of June, two thousand and twenty-one and of the independence of the United States the two hundred forty-fourth.
