1. To authorize the Board of Selectmen or other Town officials, in accordance with the Kent Policy and Procedure Manual, to apply for, accept and expend funds or grants including, but not limited to, Town Aid Road for general municipal purposes for the fiscal year 2022-2023.
2. To authorize the Board of Education or other Town officials to apply for, accept and expend funds of any federal, state or other funds or grants for educational purposes for the fiscal year 2022-2023.
3. To appropriate from Reserve Fund for capital and nonrecurring expenditures an amount equal to the expenditures approved in the Fiscal Year 2022-2023 column of the Five-Year Capital Plan.
4. To consider and act upon the recommendations of the Board of Finance for the Five-Year Capital Plan.

5. To consider and act upon the recommendation of the Board of Finance for fiscal year July 1, 2022 to June 30, 2023 inclusive and appropriate money to defray the expenses of the Town in accordance with said budget as finally accepted and established as follows:
