I'm happy to write that this will be my final COVID19 update included in the newsletter.


# Connecticut continues to lead the country with 61.1% of adults 18+ fully vaccinated!

**Easing of restrictions:** As we know by now, Connecticut lifted all COVID-19 restrictions, including capacity limits for businesses and mask requirements for vaccinated individuals. These changes are contingent upon sufficiently low rates of infections and increasing vaccination rates. Click here for more information on COVID-19 guidance and restrictions in Connecticut. #### **How is Kent doing?**

Kent continues to rank 5th in the State with +80% of its population having had at least one dose of the vaccine.



**What about the "Delta" variant?** The CDC is still learning about how this strain behaves, but vaccination does work against this variant. This reminds us to continue to stay safe, and be prepared.

**Emergency Broadband Benefit:** The FCC is offering a program to help families and households struggling to afford internet service during the COVID-19 pandemic. Throughout the pandemic, Kent Social Services has continued to support Kent residents with financial assistance, reducing food insecurity, applications for COVID related assistance, and meeting household basic needs. None of this could have been completed without the support of the greater Kent Community, both local businesses and individuals. The Kent Community Fund, in particular, has long been a steadfast supporter of the work completed by Kent Social Services. This fund really "stepped up to the plate" during the height of the pandemic by meeting the economic needs of individual Kent households as well as supporting the everchanging landscape of food distribution.

**Park & Recreation:** While The Park & Rec Commission did not want to cancel Camp Kent this year, the pandemic made it quite difficult to pull together, but Interim Park & Rec Director Miranda Lovato has hit the ground running. Here are some upcoming events, camps and clinics:

**Public Works:** Rick and the Town Crew will be sweeping the following chip-sealed roads beginning Tuesday July 6th\*:

\*Please note: timing of work is always weather-dependent. Let's all work together to keep our crews safe by obeying posted speed limits.

**Transitions:** Please welcome Interim Park and Rec Director Miranda Lovato. Her office hours will be from 9:00a to 1:00p Monday through Friday.

**Tax Bills:** Tax bills went out last week and are due by the end of July. More information is available in the Legal Notice posted on the town website. Please note: all tax bills included a document titled "Where Your Tax Dollars Go" - this document was sent out with last year's numbers in error. This is being corrected and will be distributed when available.

**Transfer Station:** 2021-2022 permits are now valid and should be visible from your rear view mirror of your vehicle.

**Glass Recycling:** Residents are doing a great job separating their glass for the new glass recycling program. A reminder that candles and drinking glasses cannot be included.

**Swap Shop:** We've had lots of requests to reopen the Swap Shop and that is the plan! We are working to make sure we will comply with State regulations once opened.



## **Civic Engagement**

We are looking for a few good volunteers! We have a number of committees that will be exploring various issues that come before the Board of Selectmen, and we would love to have you volunteer. Please contact First Selectman Jean Speck if you are interested in joining these committees:

- Broadband Working Group: This committee will work with the NorthWest Connects group to assess needs for broadband for all and make recommendations
- ARPA Needs Assessment Committee: this is in very early stages but will develop a townwide needs assessment.
- Kent Sustainability Team: The Town of Kent is enrolled in the Sustainable CT program, which will guide the work of the Team. In the coming months, the team will use the Sustainable CT framework to develop a plan for Kent.

Are you an organization in Kent looking for volunteers? We are working to compile a list to make available to the residents of the Town looking to get involved. Please email the First Selectman with the name of your organization and a contact person.

The 2021 Legislative Session was a busy one, with many important bills becoming law. Of note were these new Public Acts:

- PA 21-1 | An Act Concerning Responsible and Equitable Regulation of Adult-Use Cannabis
- PA 21-2 | The State Implementer bill, includes language to allow remote meetings to continue, and allows 'no-excuse' absentee voting for the next election.
- PA 21-58 | Better known as the "Bottle Bill", this will enact a number of new provisions:
  - 1. As of 1.1.23, expands the types of beverages that would be included such as hard cider, juice, tea, coffee, and sports/energy drinks;
  - 2. As of 1.1.2024, increases the beverage container deposit amount from 5 cents to 10 at least cents;
  - 3. Requires certain retailers to have at least two revers vending achine at their place of business.

PA 21-159 | An act concerning equitable access to broadband.

There will be much more information coming out about these and many other bills that have passed this session - we'll share new information in future newsletters.

#### **Town Updates**

**Birch Hill:** There are no updates regarding the proposed 85-bed substance use disorder treatment facility on the property at 46 Maple Street. The Town of Kent continues to monitor developments.

**Cell Tower:** The cell tower on Richards Road, approved by the Connecticut Siting Council, is currently going through the judicial appeal process, filed by a local citizen action group.

**Primary Care Office:** The loss of the sole primary care practice in Kent is of great concern to many of our residents. Families and seniors have depended on this traditional model of healthcare delivery for decades. The delivery of rural primary care is difficult, especially when juxtaposed with the business needs of a healthcare system. We know the costs of healthcare in the US are extremely high, and social and racial disparities and access to healthcare are real.

The solution may lie in the life we have all had to live over the past 15 months during the pandemic. The disruptions caused by the global COVID19 pandemic forced the healthcare industry to think outside the traditional four walls of a doctor's office, and condensed acceleration in innovative delivery of care models. We should be open to less traditional models and support the concept alternatives like telehealth and community paramedicine. The Town has been meeting with health care organizations in the state to explore some solutions.

**Streetscape**: All of the temporary easement documents from affected residents and businesses have been signed and sent in to Town Hall. This brings us closer to sending out the RFP bid packages. The committee will continue to meet as the summer progresses.

**Tribal Recognition:** Currently, there are no updates to report.
