# High Watch and Town of Kent Reach PILOT Agreement

Recently, High Watch and the Town of Kent were in discussions regarding the issue of imposing property taxes on the High Watch properties on Carter Road. During these discussions, it was recognized that as a 501(c)(3) non-profit organization, High Watch was exempt from the taxes and should have been for recent tax years and should be on into the future. I am extremely pleased to announce that through good

faith negotiations and plenty of trust and compromise, we have reached a settlement called the Payment In Lieu Of Taxes (PILOT) agreement where High Watch agrees to make one annual payment of \$30,000.00 in lieu of taxes to the Town ("PILOT payment") each year for three years, which shall be allocated and used by the Town in four equal \$7,500.00 portions in support of (a) Fire, EMS & regional paramedic services; (b) resident state trooper and public safety services; (c) public works and/or road maintenance or improvements; and (d) all other municipal services. We all know and appreciate the beneficial partnership that exists between High Watch and Kent. In addition to the wonderful programs that High Watch has in treating drug and alcohol addiction for individuals, they have been one of the of our best neighbors and friends supporting the Town through many civic activities that goes beyond any normal expected support. Most recently, it was High Watch who at the hight of COVID-19, and at their own expense, established the High Watch vaccination site at the Kent Barns serving an enormous part of Kent and the surrounding area way before the State was able to establish their local vaccination site. Also, High Watch was the first organization to actively step up to provide financial support to Kent so that we could re-establish the Resident Trooper program, thereby reducing some of the financial burden that program has on our Town budget. More recently, High Watch has opened up "Wilson's" on Main St, one of our more popular eating establishments, and has also acquired the large victorian house on North Main St (previously owned by Dolph and Audrey Trayman) and has turned it into a series of apartments that house many of the folks working at Wilson's. The other good news is that the agreement states that these locations are subject to the same Kent property tax laws as other businesses since they are not directly involved with High Watch's primary business. Bottom line in all this is we very much need and want to continue to have High Watch partner with the Town so that we can be stronger together and expand upon our mutual interests and relationships. As First Selectman, I will continue to forge better working relationships with High Watch, as well as all our local businesses, educational, civic and non-profit organizations.

Board of Selectman meetings are now on the 4th Wednesday of the Month at 6:30pm both in person in the Large Meeting Room in Town Hall as well as being broadcast on Zoom for those who can't make it in person. I encourage you to reach out to any of the Selectman if you have an issue, question, comment, and/or suggestion. during the BOS meeting, there are generally two ares in which the public can address the BOS: "Public Comment on agenda items" and "Public Comment". "Public comment on agenda items" invites the public to comment on any items on the current agenda for a time period not to exceed two minutes per speaker. "Public Comment" allows for any areas of concern to be presented to the Board by the Public. Board members may ask questions of clarification, however no further action or discussion is allowed at that meeting but can be addressed at a later time.

#### \*\*\*\*\*Important Notice to All Property Owners in Kent\*\*\*\*

I know there has been "some" consternation over the revaluation that was conducted this year. Here's some (hopefully) calming words regarding the process and what it means and what help there might be if you qualify:

Vision Government Solutions has updated the values for Kent's 2023 Revaluation to reflect the current market. The change notices have been mailed. If you did not receive one, please call the Assessor's office and we will give you a copy. Please remember that a revaluation is a revenue neutral process. The total amount of taxes that a town needs to collect is independent of the revaluation. Your tax bill will not increase the same percentage as your assessment since the mill rate will be changing. The mill rate will be set in May after the town budget is approved. If the Grand List increases significantly and the budget change is minimal the mill rate will most likely decrease. For more details about the Revaluation process please read the documents posted on the Assessor's page on the town website: www.townofkentct.org.

Although the average assessment increase for residential real estate is 37%, there is variation from house-to-house since the market desires change from one period of time to the next. In addition, if you have made any changes to your property in the past year, these changes may also have impacted your property's valuation. There is an Elderly and Totally Disabled Tax Relief Program available for those who are below the qualifying income levels set by the State of Connecticut. Please contact the Assessor's office after the first of the year for more information.

Our resident state trooper has two reminders for all citizens:

- <u>Safety when traveling:</u> The weather is unpredictable this time of year, but the
  most unpredictable part of traveling is the "other guy!" If you're out on the
  highways and byways, watch out for speeders and those that seem to be in a
  huge hurry. Don't engage in any road rage and remember to dial 911 if in an
  emergency situation.
- Phone & in-person scams: There are a number of scams that CT State Police are investigating, and Trooper Fisher recommends a good rule-of-thumb is to only answer a phonecall if you recognize the number, and never allow anyone

to come to your house unless you initiate it. A legitimate business would not show up at your home unless you're conducting business with them.

#### Road Foreman/Public Works

With the amount of rainfall we have had this year there are a number of roads where water is running where it normally does not. We deal with these spots as they develop, some start the day of a storm others appear days later. Some areas have a

lot of ledge outcroppings along the road edge so we cannot clean swales along the shoulder. In these areas we clean out by hand, there is often a very narrow water-way where a stick or leaves can block the drain and make the water run into the road. In those cases when the weather freezes the water run-off, we are forced to salt and sand to make the roads safe for traffic. Although it may appear to be massive amounts of salt being used, it really isn't. We concentrate dropping the salt along the edge of the water instead of the width of the road as normally applied so anything that overflows will be brine and not freeze in the road.

We have small but dedicated Town Crew who work hard to address all the problems of water flow, road flooding/freezing as quickly as possible, however during these winter months, the use of salt and sand are often the only option available.
