VA Strengthens Caregiver Support Program Under the VA MISSION Act of 2018, The Department of Veterans Affairs (VA) will expand the Program of Comprehensive Assistance for Family Caregivers (PCAFC) to eligible Veterans from all eras using a phased approach. Currently, the program is only available to eligible Veterans seriously injured in the line of duty on or after September 11, 2001. Prior to expanding, VA must upgrade its information technology (IT) system and implement other improvements to strengthen the program. For further information go to:

Town Business & Reminders

Energy Assistance Program: Beginning in September, Kent Social Services will be scheduling appointments for the CT Energy Assistance Program (EA). Kent Social Services serves as a voluntary intake site for all Kent residents that qualify for EA. Application review and final approval is completed by Community Action Agency of Western CT. During the winter months, this program assists with the purchase of heating fuel including oil, propane, kerosene, electric, wood, and wood pellets. EA has specific gross income and asset limit requirements. Since the entire household benefits from this program, income and asset verification will be required for all adult household members. For example, this year's gross income guidelines are: Household size 1/ Max income \$36,171.00; Household size 2/Max income \$47,300.00; Household size 3/\$58,430.00; etc. To determine if your household qualifies for this program or to schedule an appointment, contact Leah Pullaro, Kent Social Services 860-927-1586.

IMPORTANT FISH INFORMATION

Please remember to schedule a ride at least three working/business days in advance.

For example, if you need a ride on Friday, call Town Hall at 860 927-4627 on Tuesday at the latest. Or call earlier, if possible, especially when you make an appointment in advance. If a volunteer is not available on a given day, you may be asked to reschedule your appointment.

FISH volunteers provide transportation to medical and dental appointments only outside of Kent and to medical and dental appointments, the IGA, hairdresser, Food Bank, banks, etc. within Kent. Medical appointments take priority over other kinds of rides.

FISH clients must be ambulatory and be able to get in and out of a vehicle on their own. FISH provides rides when family members, neighbors, the NW Transit District bus and other options are not available – and when volunteers are available. Rides are provided Monday through Friday before 5 p.m. and not on holidays.

For longer rides, FISH will encourage use of the free RITS Program (Rural Independent Transportation Service through Northwest Transit District (860-489-2535). More information about these options will be shared in coming months.
