TIPS FOR CONSUMERS TO STOP ILLEGAL ROBOCALLS.

There is no completely effective method to stop unwanted robocalls, and the real solutions require that the Federal Communications Commission use the laws effectively to regulate robocallers and require phone companies to authenticate all calls. Yet, the following tips can help callers take some control:

- 1. File complaints with the **Federal Communications Commission (FCC)** 888-225-5322.
- 2. Add your number to the **Do-Not-Call list** 888-382-1222.
- 3. **Revoke consent:** If you are receiving phone calls from a company you do business with, they likely have your consent, hidden in fine print, to robocall you. You can revoke your consent at any time. Tell the caller you "revoke consent". If the calls continue, contact customer service and tell them you do not consent to receive calls and that you want your number added to their do not call list. This won't stop illegal scam calls but it will reduce the volume of robocalls that you receive.
- 4. **Don't engage with the caller:** Most autodialed robocalls include a prompt to press a key or give a voice command. DON'T! Pressing a key, even if the recording says it's to remove your number from the list, tells the caller that your number is active and that you'll likely answer future calls. Even worse, the voice commands can be recorded and used against you by scammers to represent consent to purchase products or services.
- 5. If possible, **block or do not answer calls from unknown numbers** on your mobile device.
- 6. **Install call blocking apps:** Various call blocking apps, like YouMail or NoMoRobo, provide a free or low-cost service to mobile smart phone users that filter out identified scam robocalls and allow users to block specific numbers and report the calls. However, typically these apps don't help landline users.

Town Business & Reminders

Energy Assistance Program: Beginning in September, Kent Social Services will be scheduling appointments for the CT Energy Assistance Program (EA). Kent Social Services serves as a voluntary intake site for all Kent residents that qualify for EA. Application review and final approval is completed by Community Action Agency of Western CT. During the winter months, this program assists with the purchase of heating fuel including oil, propane, kerosene, electric, wood, and wood pellets. EA has specific gross income and asset limit requirements. Since the entire household benefits from this program, income and asset verification will be required for all adult household members. For example, this year's gross income guidelines are: Household size 1/ Max income \$36,171.00; Household size 2/Max income \$47,300.00; Household size 3/\$58,430.00; etc. To determine if your household qualifies for this program or to schedule an appointment, contact Leah Pullaro, Kent Social Services 860-927-1586.

Seasonal Flu Clinic: Seasonal flu vaccination clinic will be offered Wednesday, Oct. 21, 2018 for Kent seniors from 10 to 11 a.m. and any age resident from 11 a.m. to noon in Kent Town Hall, first floor large meeting room. Accepted insurance plans will be announced. Registration forms and related information packet are available at the Kent Senior Center, Swifts Lane, and in the Kent Town Hall lobby. The clinic is sponsored by the New Milford Visiting Nurse Association and Kent Community Fund in conjunction with the Town of Kent. For more information, call Lesly Ferris at 860-927-1003.
