Mr. Manes moved to not object to High Watch's withdrawal of the High Watch Recovery Center, Inc., v Kent Planning and Zoning Commission; Birch Hill Recovery Center, LLC; Kent Realty, LLC lawsuit. Mr. Wyrick seconded and the motion carried unanimously.

5. Training Session

Acting Chairman Winter explained that this is an opportunity to ask Attorney Zizka legal questions for the purposes of training.

Donna Hayes discussed signage and whether the design of a sign is considered content. She explained that this has become an issue with the ARB. Attorney Zizka explained that constitution dimension is not content based. The court says you cannot regulate an advertising sign. Size, location and lighting are the only reasons you can regulate a sign. Type face or design cannot be regulated because of statutory limitation regarding advertising signs. Persuasive reasons are needed to be provided by the ARB as to why a design does not meet the regulations. The ARB is a process which requires that an application is referred to them, but ultimately the P&Z Commission has the final decision on the matter

Attorney Zizka discussed the suggestion made by a Commission member that he be present at each meeting to represent the Commission. He noted several disadvantages to this including the loss of opportunity in the moment to discuss legal matters in an executive session. He feels that the communication via Land Use staff on specific issues is a better way to address the Commission's legal concerns. He will usually provide a letter to the Commission when asked for a legal opinion on a specific matter.

Wes Wyrick was dismissed at 8:51 pm.

6. ADJOURNMENT

Mr. Manes moved to adjourn at 9:00 p.m. Mr. Cherniske seconded and the motion carried unanimously.
