Present: Bruce Adams, Susi Williams and Mike VanValkenburg.

Also present: Pamela Dudgeon-Eisenlohr, Donna Hayes, Bill Jenks, John Johnson and Lynn Werner

Mr. Adams called the meeting to order at 6:04 p.m.

Mr. Adams made a motion to move to Executive Session for the purpose of discussion and possible action regarding the job performance of the Land Use Clerk, Pamela Dudgeon-Eisenlohr and in addition to the members of the Board of Selectmen and Ms. Dudgeon-Eisenlohr, I would invite Donna Hayes, Bill Jenks, John Johnson, Joyce Kearns and Lynn Werner into the Executive Session at 6:05 p.m.

Ms. Dudgeon-Eisenlohr stated that the meeting could be held in public session.

Mr. Adams stated that it was on the recommendation of Land Use Administrator Donna Hayes, Building Inspector Bill Jenks, Planning and Zoning Chairman John Johnson and Inland/Wetland Commission Chairman Lynn Werner to terminate Ms. Dudgeon-Eisenlohr's employment with the Town of Kent effective immediately due to unsatisfactory job performance and failure to assimilate into a position. The Town has issued two checks: one for January 6<sup>th</sup> and 7<sup>th</sup> and one for two weeks of pay in lieu of notice which will be given to Ms. Dudgeon-Eisenlohr once the key to Town Hall and any other Town property is returned to the town.


Ms. Dudgeon-Eisenlohr stated that she thought that the purpose of the meeting was to discuss her performance not to be terminated. Mr. Adams stated that the Board of Selectmen were acting upon the recommendation of four different professionals that have direct dealings with Ms. Dudgeon-Eisenlohr.

Mr. Adams made the following motion:
